## **ShalomBASE Financial Policies**

Tuition is paid on a ten (10) month annualized rate. We have taken holidays and planned vacation time into account. For ease of payment, the annualized rate is broken in to 10 equal payments.

A non-refundable deposit equal to two months' tuition for each child is due by June 1, 2024. One month's tuition (September 2024) will be billed upon enrollment and required to secure your child's spot. The remainder of the deposit (June 2025 tuition) will be billed on May 15, 2024, and due no later than June 1, 2024. Deposit payments are completely nonrefundable.

Eight (8) monthly payments are due (October 2024 through May 2025) on the first of the month. Families will be invoiced monthly on the 15th of each month starting in September for October 1st payment. Payments received after the 10th of the month will be assessed a \$25 late fee. Families are responsible for any fees associated with checks returned for insufficient funds plus a \$25 handling/processing fee.

Payments can be made via check (made payable to Temple Ohabei Shalom) or through your ShulCloud account. An invoice will be sent to you via email.

Those who choose to withdraw after the start of the school year and before March 1, 2025, must give thirty (30) days written notice to the Program Director and their tuition deposit payment will be applied to the child's final month of attendance. Families who choose to withdraw after March 1, 2025, are required to pay for the school year in full.

Tuition adjustments or refunds will not be made if a child misses school due to illness, vacation, or otherwise, and will not be made if ShalomBASE is closed because of weather or governmental orders related to public safety (except as noted in the financial policies below).

In the event of a closure due To COVID-19 (or other such illness): If ShalomBASE is required to close one or multiple classrooms due to COVID-19 (see illness policy) and/or there is a state or town-mandated closure, there will be no refunds given for the first two weeks (10 school days) of closure. If any classrooms must stay closed longer than ten (10) school days, families of children in that class will be refunded for each scheduled school day's tuition paid at a prorated rate until we can re-open; however, we will retain your deposit payment throughout the school year. If/when we return to school during the 24-25 school year, you will be responsible for paying your tuition effective the first day of reopening, regardless of whether you choose to send your child. In the case of multiple classroom closures during the 24-25 school year, families will be required to pay 75% of their tuition for the first 10 school days (or less) of closure for each subsequent occurrence.
